A regular meeting of the Board of Trustees of the Village of Cooperstown was held at the Village Office Building, 22 Main Street, Cooperstown, New York on December 22, 2014 at 6:30 p.m. Members in attendance were Mayor Jeff Katz, Trustees Ellen Tillapaugh, Cynthia Falk, James Dean, Bruce Maxson, Joan Nicols and Louis W. Allstadt. Also in attendance were DPW Superintendent Brian Clancy, and Village Clerk – Teri Barown. There were four (4) members of the public present.

Mayor Katz called the meeting to order at 6:30 p.m. and led the pledge of allegiance.

Public Comment – There were no comments from the public.

Minutes – Dr. Falk made a motion to approve the October 27, 2014 minutes with corrections noted in an email to the Clerk from Trustee Falk. Ms. Tillapaugh seconded the motion and a vote had the following results:

Zoning Officials Report – Mayor Katz reviewed the Zoning Officials Report as provided in the Trustee packet and stated that Mr. Austin was unable to attend tonight's meeting.

Mayor Katz made the following appointments to the Historic Preservation and Architectural Review Board: Teresa Drerup reappointed to a 3 year term as Chair/Member, effective January 1, 2015, David Sanford appointed as member of HPARB for a 3 year term effective January 1, 2015 in the spot vacated by Wendall Tripp and Ann Stewart appointed as alternate Member of HPARB effective January 1, 2015 for a 3 year term.

Ms. Tillapaugh made a motion to ratify the appointments as made by Mayor Katz. Mr. Allstadt seconded the motion and a vote had the following results:

Discussion was held regarding the need to condense the draft PUD law as prepared by Matt Rogers, it was suggested that this be referred to Planning Board for this purpose together with asking them to also re-visit the sign law for recommended changes and review of the draft vending law.

Dr. Falk made a motion to accept the Zoning Official's Report as submitted. Mr. Allstadt seconded the motion and a vote had the following results:

Police Committee – A copy of the December committee report was provided in the Trustee packets.

Ms. Tillapaugh noted that the committee discussed Chief Covert pursing inclusion of funding for body worn cameras in his 2015-16 budget proposal. Chief Covert stated that President Obama has promised that funding for these devices will be forthcoming.

Dr. Falk asked that if the Chief found specific classes regarding sensitivity training that information be provided to the Head of Security at SUNY Oneonta as they are also looking into it.

Fire Committee – A copy of the December Fire Committee report was provided in the Trustee packets.

Discussion was held regarding the squad being toned out for non-emergency calls at FOCUS (previously Otsego Manor). Ms. Tillapaugh stated that Chief Tallman has had a conversation with the Nursing Home Administrator regarding this issue and will be speaking with the owners of the company in the near future.

Mayor Katz stated that this speaks to the issue of the squad becoming a corp so that they can charge for the calls. He stated that maybe this issue should once again be looked into.

Ms. Tillapaugh noted that there have been some instances of delivery trucks for Mels at 22 blocking the fire lane. She said we may want to consider either making the proposed 15 minute spots or the trolley stop up for discussion at tonight's public hearing into a loading zone.

Mr. Allstadt stated that we may have some further assessment of the energy needs for the meeting room regarding LED forthcoming.

Ms. Tillapaugh made a motion to accept the Public Safety Committee reports as presented. Dr. Falk seconded the motion and a vote had the following results:

Doubleday Field Advisory Committee – There was no committee meeting this month due to closure of the Village Office for inclement weather.

Following discussion Mayor Katz made a motion to renew the option for John Kosmer for the 2015 season. Mrs. Nicols seconded the motion and a vote had the following results:

Dr. Falk noted that the Trustees will hold a workshop in preparation for the 2015 paid parking season to discuss elements for inclusion in the proposed local law for 2015 on January 5, 2015 at noon and will also hold a workshop for a presentation from Barton & Loguidice for preliminary plans on the TEP project on January 6, 2015 at 3:00 p.m.

Mr. Allstadt made a motion to accept the Streets Committee report as submitted. Ms. Tillapaugh seconded the motion and a vote had the following results:

There was no comment from the public regarding the public hearings. Mayor Katz stated he would leave them open for a time and continue with the regular agenda.

Buildings Committee – A copy of the December committee report was provided in the Trustee packets.

Mr. Allstadt made a motion that a letter will be sent to the proposed contractor for window replacement at the fire hall that if required documentation is not received by January 15, 2015 the contract will be cancelled and given to the next lowest submission. Ms. Tillapaugh seconded the motion and a vote had the following results:
