#### Village Did Not Adopt "Sanctuary City Law"

The Village of Cooperstown did not adopt a "Sanctuary City Law" at its April 24 Board of Trustees meeting. Any reports to the contrary are completely false.

In response to national and international incidents, the Village of Cooperstown steadfastly confirms its dedication to the rights and dignity of all people. In December 2016, the Board of Trustees passed a resolution condemning the use of violence, bigotry, and hateful rhetoric, and reaffirming the inalienable right of everyone in Cooperstown to live without fear and intimidation.

On April 24, 2017, the Board of Trustees passed a second resolution reaffirming its commitment to civil rights and equal access to all Village services, including police and fire protection. The resolution states that the Village of Cooperstown will not avail itself of the opportunity to participate in the Delegation of Immigration Authority provided through Section 287 (g) of the Immigration and Nationality Act (1996). The Village has neither the resources nor the desire to designate local police to perform immigration law enforcement functions.

In general practice the Village of Cooperstown will not inquire about the immigration status of crime victims, witnesses or others who call or approach Village staff seeking assistance. There is, however, nothing in the resolution that prohibits Village staff from cooperating with federal immigration authorities when required under federal law. #### Incentives for Commercial Projects

The Village of Cooperstown is pleased to continue two property tax abatement programs for commercial and mixed-use buildings. These programs do not affect current tax assessments, but they do allow for the gradual phase-in of increased value when improvements are made. As a result, increases in property taxes are incurred more slowly, allowing building owners to better prepare and recoup some of their costs without a dramatic spike in assessed value.

The first program provides an incentive to make improvements to existing commercial buildings or for new commercial construction. Approved renovations or new construction by businesses may be eligible for a 50 percent exemption of real property taxes on all improvements for the first year. After the first year, assessed value would be increased by 5 percent per year until the eleventh year, when the property becomes fully taxed.

The second program is for the conversion of nonresidential real property to mixed-use property, when the cost exceeds \$10,000. Often this means the conversion of underutilized commercial upper floors to apartments. For the first eight years, increased assessed tax value as a result of an approved conversion would be 100 percent abated. In years 9 to 12, the new assessed value would be phased in, increasing 20 percent per year.

Additionally, businesses can qualify for both state and federal historic preservation income tax credits. Owners of income-producing real properties listed on the National Register of Historic Places, including those contributing in our Glimmerglass Historic District, may be eligible for a 20% federal income tax credit. The work performed (both interior

and exterior) must meet the Secretary of the Interior's Standards for Rehabilitation and be approved by the National Park Service. Owners who qualify for the federal credit can also take advantage of a 20% state income tax credit. #### Want Money for Repairing your Historic Home

If you live in the Village of Cooperstown and your house was built before 1949, you might qualify for a state income tax credit for work on your home. New York State offers income tax credits for homeowners in qualifying census tracts (of which ours is one) who do more than \$5,000 of approved work on their historic house. At least 5% must be spent on the exterior of the home, and all work must be approved by the State Historic Preservation Office before it begins. The tax credit is equal to 20% of approved qualifying expenses up to \$50,000. For more information, contact the State Historic Preservation Office at (518) 237-8643 or Otsego 2000 at 547-8881.

#### **Outdoor Dining and Vending**

In 2013 the Village of Cooperstown first began permitting outdoor eating areas. We are happy to see that so many local eateries have been able to take advantage of outdoor dining. It provides the perfect opportunity for locals and tourists to enjoy great food and a beautiful streetscape in an increasingly accessible environment.

This summer we are adding to the mix by promoting sidewalk vending in the business district on Wednesday evenings. Fees will be waived this inaugural year.

#### Are you a musician or artisan?

In a joint effort of the Village of Cooperstown and the Cooperstown Chamber of Commerce, this summer Music on Main will continue. Musicians will be performing in Pioneer Park, and artisans who would like to demonstrate a craft may also participate. #### **Upcoming Street Work**

During early June the Village intends to get a jump on this year's street work. Pioneer Street from Beaver to Elm, Elm Street, Grove Street from Glen to Maple, and the firehouse apron will all be repaved. Property owners on the effected streets who anticipate conducting work on their water or sewer laterals in the near future are encouraged to contact Village Administrator Teri Barown at 547-2411 as soon as possible to coordinate scheduling. With proper planning we can avoid the need to dig up a freshly paved street to address utility concerns.

The Village is also planning a major reconstruction project on Pioneer Street north of Elm to begin fall 2017 and continue in spring 2018. Stay tuned for additional information as it becomes available.

#### **Downtown Parking Permits & Paid Parking**

The implementation of paid parking while remain the same in 2017. The season will run from the Friday before Memorial Day through Columbus Day. The paid parking area includes the same portions of Main, Chestnut, Pioneer, and Fair Streets. And, the rate remains \$2 per hour, payable in 15-minute increments, with a \$14 all-day option at the Doubleday Field parking lot. On the streets, parking will continue to be limited to a 2-hour purchase, with the ability to buy additional time by re-upping at a Pay and Display Machine. Doubleday Field provides an all-day option.

Downtown parking permits provide an alternative to using Pay and Display machines for parking in the paid parking area. Anyone—local or tourist—can buy a permit. Permit holders can park for up to 2 hours daily in 2-hour areas without purchasing a ticket from a Pay and Display machine. The same permit can be used to park in the Doubleday Field lot after 4 pm and all day in the permit-only Fowler Way parking lot (located behind the Chamber of Commerce) if an all-day option is needed. Please remember that the purchase and display of a parking permit does not guarantee a parking space.

Parking permits can be purchased in person from the Village Clerk's office at 22 Main Street or by mail or email. Applications can be accessed on the village website <a href="www.cooperstownny.org">www.cooperstownny.org</a> (under permits) or at the Clerk's office. A completed application must be accompanied by the appropriate fee, payable by cash or check. Credit cards can be accepted at the Village office. Permits remain a great deal at a cost of \$25 for the first permit, and \$15 for additional permits at the same address.

#### **Annual Drinking Water Quality Report**

The Village of Cooperstown has prepared its annual Drinking Water Quality Report to comply with State regulations. The purpose of the report is to raise your understanding of drinking water and

awareness of the need to protect our drinking water sources.

Last year, your tap water met all State drinking water health standards. You may access a complete report at the Village website <a href="https://www.cooperstownny.org">www.cooperstownny.org</a>, pick up a copy at the Village Office, 22 Main Street, or call 607-547-2411 to request a copy be mailed to you. The report will provide you with an overview of last year's water quality. Included are details about where your water comes from, what it contains, and how it compares to State standards.

#### Village Parks Projects

The new boat wash station on Fish Road will be dedicated in memory of long time "Lake Steward," Carl Good on Friday, May 12, 2017 at 5 p.m. Please attend this brief ceremony honoring Carl and recognizing the importance of the boat wash station in preventing aquatic invasive species from entering Lake Otsego. The Village appreciates all the efforts and funding provided by OCCA and the Otsego Lake Association in constructing the station.

In order to address the wait list we had last year for our canoe/kayak racks, the Village crew constructed three new vertical kayak racks and will install one each in Lakefront, Fairy Spring and 3 Mile parks. Contact the Village Office at 547 2411 if you would like to rent one of these spaces. The rates are just \$75 in Lakefront Park, and \$50 in Fairy Spring or 3 Mile (for non-Village residents, rates are \$150 in Lakefront Park and \$70 in Fairy Spring & 3 Mile parks). The Friends of the Parks helped pay for two of the new racks and in addition, the Friends have donated a kayak cart for Lakefront Park, to assist boaters in transporting their canoe or kayak to the Lake. The cart will be kept locked with the combination available to individuals renting a rack space.

Parks Board member Rich McCaffery has once again lined up a great schedule for our Tuesday night Lakefront Concert Series. Check out this year's schedule of concerts contained in this newsletter and bring your lawn chair to enjoy this wonderful, free entertainment on the shores of Lake Otsego!

AND FINALLY... this spring the Village will at long last repair the deteriorating retaining wall and roadway by the Pavilion at Fairy Spring Park. It is hoped that we will also be able to replace the steps to the waterfront during this construction and separately we have budgeted for the repair of the chimney on the Pavilion. We will finish up with new paving on the roads in Badger Park, Fairy Spring and Fish Road. So plan on using and enjoying your Village Parks this summer!

#### Village Parks

Looking for an inexpensive family outing? Fairy Spring and Three Mile Point parks are free for Village residents. Both parks will open for weekends beginning Saturday, May  $27^{th}$ . On Saturday, June 17th the weekend prior to high school graduation, the parks will be open seven days a week. Three Mile Point Park opens at 10 AM and Fairy Spring Park opens at 11 AM both remain open until dusk with swimming as staffing permits. (The staff works diligently to ensure lifeguards are on duty at both parks whenever possible however there are times when one or both parks shut down the swimming areas due to lack of staff.)

Village residents may get their free park pass at either park or at the Village Office with just their identification which includes their village address. This pass will allow you and your immediate family (i.e. 2 adults and their children, living within the same household), access to either Fairy Spring or Three Mile Point Park (If your family chooses to bring guests they will either need to purchase their own pass or pay \$5.00 per person admission price at the park.)

To ensure a family friendly environment and the safety of all patrons we remind you:

- Alcoholic beverages are not permitted;
- Pets must be leashed at all times and owners must clean up after pets.
- Charcoal grills and picnic tables are available for your enjoyment;
- Pavilions are available on a first come first serve basis unless rented to a group or organization;
- To carry out whatever you bring in (i.e. food, garbage, bottles, cans, etc.);
- Parking is limited, please car pool if possible

#### Tree City

The Village of Cooperstown is pleased to announce that for the 27<sup>th</sup> year it has been named a Tree City USA by the Arbor Day Foundation.

The Village of Cooperstown held its annual Arbor Day celebration on Monday, April 24. This year's Arbor Day tree, planted in front of 28 Elm Street across from St. Mary's Catholic Church, memorializes the life of Father John R. Roos. Father Roos, who passed away January 3, 2017, had served Catholic churches in Cherry Valley, Springfield Center, and Sharon Springs, as well as St. Mary's in Cooperstown.

Cooperstown's Arbor Day celebration included a proclamation by Mayor Jeff Katz and a presentation by DEC forester Scott Moxham. Arbor Day began in 1872 in Nebraska City, Nebraska. The event, held in late April or early May across the country, is

meant to recognize and support the planting of trees, which provide many benefits to local communities like Cooperstown.

We look forward to planting eight more Village trees in the coming weeks.

#### **Grate Keepers**

The Village of Cooperstown expresses its sincere thanks to the various residents/businesses/organizations who have so willingly adopted a drain to help keep storm water flowing as it should especially during and after heavy rain storms. Do you know there are 313 drains throughout the Village? This is an enthusiastic charge to keep them clear, so we can keep our roadways safer, especially during rain storms.

The Village will continue monitoring storm drains, but the assistance of volunteers will reduce the possibility of flooding due to inoperable or clogged drains, especially in light of the more frequent and severe storms we have been seeing.

When the forecast calls for a heavy rainfall, snow, or ice, remove the debris from each catch basin prior to a storm. Stand on the curb and use a rake or pitch fork to clear leaves, limbs, and debris from the catch basin. Do not attempt to remove the grate, only the debris on top of the grate.

If you see a catch basin filled with debris below the grate, or if you cannot clear the grate yourself or notice any other problems with the drain, please notify the Village at 547-2411 and report the particular location. Never remove the grate or put debris into the drain.

#### **Trolley Passes**

The trolley season will soon be underway. Season trolley passes are a bargain and great way for local residents and employees to find transportation around Cooperstown.

The trolleys run daily, from 8:30 AM – 9 PM beginning Saturday, May 27th. Season passes are \$35 for a family; \$20 for an adult; \$15 for a senior citizen and \$10 for students under 18 years old. You can purchase season passes at the Village Office, or on the trolleys.

This season trolley riders will be able to track the progress and location of the Cooperstown trolleys on a smartphone friendly website at www.cooperstowntrolley.com. Refreshed every 2.5

seconds, GPS will provide the location of the nearest trolley, as well as the others in operation.

#### **Driveway Blocked**

Parking in front of public and private driveways is prohibited under New York State law. If you have an ongoing problem with people obstructing your street visibility or blocking your driveway and you feel that yellow curbing on either side of your driveway would be helpful, you can apply for yellow curbing to remind motorists of their responsibility not to block your driveway. #### Spring Clean Up

For the past month the Village crew has been regularly picking up green waste to coordinate with spring yard work. Beginning the second week in May the Village will limit green waste pickup to the last Thursday of each month.

Compostable Waste and Brush Curbside Pickup Procedures:

- The Village will pickup compostable yard waste and brush separately. There will be two pickups per street, one for soft green waste and a second for brush.
- Place any soft green waste such as grass clippings, leaves, and other soft garden waste in compostable bags or in reusable hard plastic containers.

Place containers between the sidewalk and the curb.

- Do not use plastic bags.
- Do not include noncompostable materials like plastic flower pots.
- Do not assume that we can lift containers that you cannot lift. Containers that are too heavy will be left at the curb.
- 3) Place brush in a pile between the curb and sidewalk.
  - Do not put brush in containers.
  - Keep brush separated from green waste.
  - Root balls, stumps, and large tree limbs will not be picked up. We can only

take material that will go through our shredder.

 We do not pick up any kind of construction debris or processed lumber.

Residents may also bring green waste at any time to the Village Street Garage on Linden Avenue and deposit it themselves in the appropriate area. Commercial dumping is prohibited.
